■ Eligibility Criteria

An Applicant who has graduated in any discipline of knowledge from a university established by an Act of parliament or by a state legislative or any equivalent National Institution recognized and deemed to be university or Foreign University recognized as equivalent may apply for a three years degree course in law.

As per BCI rule to be Eligible for admission into the law three- year degree course, the minimum percentage of marks should not be below 45% of the total marks in case of General Category application and 40% of total Marks in case of SC/ST applicants. It is Mandatory.

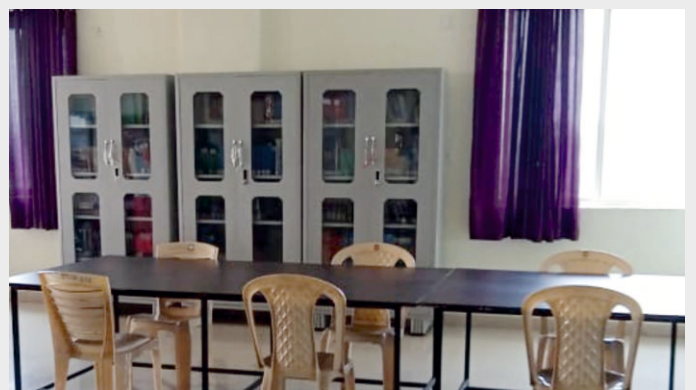
